District and Province aforesaid Farmer

of the other part, witnesseth, That for and in consideration of the sum of

current money of the Province of Canada, to the said Chandler S.  
Heath — in hand paid by the said Hiram

Heath at or before the execution of these presents, (the re-  
ceipt whereof is hereby acknowledged by the said Chandler S. Heath  
~~Heath~~) he, the said Chandler Heath

hath granted, bargained, sold and confirmed, and by these presents doth  
grant, bargain, sell and confirm, unto the said Hiram

Heath his heirs and assigns forever, all that certain lot and  
Maitly of land known and distinguished by the South  
Westerly part of that maitly and parcel  
of Land bought by th. Said Chandler  
S. Heath of the Crown off the said  
Latmunder Elden in the Eighth  
Range of Lots in said Broome Containing  
thirty nine acres in superficies with

all the improvements thereon erected,  
a Survey Bill of said Maitly being hereunto attached

To have and to hold the said lot of land and premises, herein before grant-  
ed, bargained and sold, or intended so to be, with their and every of their appur-  
tenances, unto and to the use of the said Hiram Heath —  
his heirs and assigns forever.

At the request of Abram Fleath and  
Chandler Heath of the Township of Brom  
District of Montreal yeomen

I the undersigned Land Surveyor of the  
Township of Bromme List aforesaid did  
repair to the part of the Township of  
Bromme known as lot number Eleven  
in the Eighth Range there being I  
Range no. in pence at a post it being the  
South Westerly corner boundary of the  
parcel of land owned by Chandler Heath  
and taken from the East end of the  
aforesaid lot measuring to the East  
on the Southerly line of the same  
seventy two rods and planted a post  
thereof North twenty one degrees East to  
the Northerly line of the same thirty  
five rod East of the West Westerly  
corner boundary of the aforesaid parcel  
and planted a post thus taking from the West  
end of the aforesaid parcel a certain tract  
or parcel of land containing thirty nine acres
